AGRICULTURAL LIMING MATERIALS REPORT

JANUARY 1 THROUGH JUNE 30, 2002

This bulletin is a detailed report of official samples obtained under the Missouri Agricultural Liming Materials Law collected from January 1 through June 30, 2002. There were 849 official samples collected in this period. All samples are analyzed to determine fineness of grind, calcium carbonate equivalent (CCE), and magnesium content (Mg). Effective neutralizing material (ENM) and effective magnesium (EMg) are calculated from this information, as prescribed by Rule, for each dry sample which meets the minimum specifications of at least 90% passing a U.S. No. 8 sieve and minimum 65% CCE. Products not meeting minimum specifications cannot be sold as agricultural liming materials. Twenty-eight deficient samples are reported, twenty-five for excessive coarseness and three for low CCE. There were two "stop sale" order's issued against producer stockpiles for excessive coarseness. Corrective actions taken by the producer has resulted in the release of one of the issued "stop sale" orders.

Table 1 lists registered producers and samples obtained at production sites. Table 2 lists samples obtained from retail distributor stockpiles, by producer.

Liming Still Pays on Cotton

Soil pH is the cornerstone of a good fertility program. Without soil testing results to guide farmers' decisions, crops do not produce optimal yields either because soils are excessively acid (low pH) from not having enough lime applied or alkaline (high pH) from having too much lime applied. When nitrogen fertilizer is applied to crops without periodic liming, soils become progressively more acid over time. Low pH (soil acidity) reduces the availability of important nutrients such as phosphorus to crops and increases the availability of aluminum and manganese resulting in toxicity. In the past many Missouri farmers used the "three tons of lime every three years" rule of thumb without soil testing. This practice sometimes caused soil pH in crop fields to become too high which resulted in crop micronutrient deficiencies.

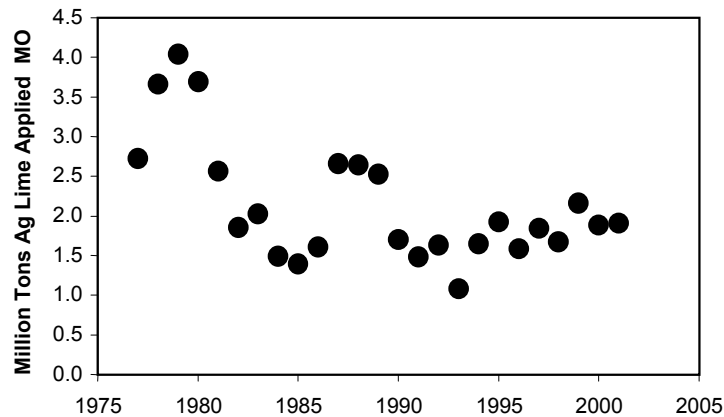


Figure 1. Annual tons of lime applied in Missouri from 1976- 2002.

During the farm crisis of the early 1980's, farmers started to use less lime to save on input costs (Figure 1). Lime use increased briefly in 1987 when farmers received cost sharing to apply lime from the Conservation Reserve Program. However, after 1989, lime use dropped again. Although commodity prices rebounded for some crops in the early 1990's, lime use did not increase. In many fields, farmers were not applying enough lime to keep pace with acidification resulting from nitrogen fertilizer applications.

Shortly after I began working at the University of Missouri-Delta Research Center at Portageville in 1994, I received several phone calls from cotton farmers requesting field visits to help them determine why their crops were "sick". In the majority of the cases, soil tests showed that the problem was low soil pH. Some fields had soil pH_{salt} values less than 4.0. In 1996, we began an extension program to educate Southeast Missouri farmers on the importance of soil pH in preventing Al and Mn toxicity and maximizing the availability of other nutrients. Information was distributed to farmers through extension cotton meetings, field days, magazine articles, and radio announcements.

In Southeast Missouri, we found that a major factor contributing to the low pH problem in Southeast Missouri is absentee landowners. Landowners are sometimes heirs with little or no experience in crop production. Crop share rental agreements usually require the landowner to pay a share of the fertilizer costs each year. Because lime is normally not applied every year, landowners often resist helping buy lime when it is needed. Changing the behavior of landowners is difficult because they do not usually read agricultural magazines or attend extension meetings and field days. Sometimes they do not even live in the state of Missouri.

Many landowners and farmers know that liming fields with acid soils is a "good" practice, but question whether it provides a return on investment in today's ag economy. The answer is yes. By applying economics to recent lime research results at the Delta Center, we found that liming still pays. Tables 1 and 2 show the results of field experiment with red (dolomitic) and white (calcitic) lime treatments on cotton. The initial soil pH_{salt} in the plots was 4.6. Although the white lime caused a more rapid pH increase than red lime in 2000, the increase in cotton yields for the two limes as compared to the untreated check were about the same (Figure 2). Two-year average lint increase from lime was 113 to 129 lb lint per acre. Using 52 cent a pound cotton, the gross return from applying lime was \$59 to \$67 per year. At \$20 per ton using 2 tons per acre (\$40 per acre), the lime paid for itself in one year.

David Dunn and I have another lime test that we will be discussing in the future. In 2002, we began a soybeans and corn study funded by Missouri fertilizer/lime tax funds to determine whether lime should be incorporated with tillage. Red and white lime were applied on no-till, strip-till and conventional till plots. In addition to crop yields, we are monitoring soil pH in 2-inch increments in the profile.
